### **Our Privacy Policy**

Federal law requires us to tell you how we collect, use, share, and protect your personal information. Federal law also limits how we can use your personal information. ### **Purpose of This Notice**

We restrict access to non-public personal information about you to those employees who need to know that information in order to provide products and services to you. We maintain physical, electronic, and procedural safeguards in compliance with federal standards to protect your nonpublic personal information.
